Thanks to tireless fundraising efforts last year and generous donations from supporters like you, Grace & Mercy Charitable Foundation was able to obtain our own buildings. It has made it possible for us to expand the services provided to our community. The first building that we house is our office, warehouse and My Girlfriend's Closet which provides high end clothing for potential job seekers as well as every day wear for those in need. The second building, OUR SOUP KITCHEN, is open on Mondays and Wednesdays from 9-1 for freshly prepared hot meals. We also open the buildings on days of inclement weather so that our clients can come in from the cold.

Our goal is to facilitate transitioning people into jobs and their own permanent residences. We have a mobile health company coming on a regular basis to do minimal things such as blood pressure checks. We also continue to help with financial needs that arise such as, dental emergencies, transportation needs, prescription medical needs, sleeping bags, blankets, socks, gloves and other clothing needs. We never give out cash but find constructive ways to help people with their daily challenges. Most recently, we have been able to help one of our clients with cancer treatment medicine and lodging for her and her family. A few years ago we paid for a rape victims transportation home to her family, we paid for utility bills for a family that had severe medical needs, we paid for hotel bills for a woman and her children who were going to be out on the street. These kinds of issues are prevalent in the homeless community and we do what we can to help with the limited resources that we have.

Our goal at Grace & Mercy is to insure that no one in our community goes hungry and that as a community we pull together to make this a safe, healthy environment to live in and raise our families. We sincerely believe that many people just need that little bit of help or encouragement to someday be leaders and volunteers themselves. We have already witnessed the impact our foundation has made on many people who have bettered themselves and began to prosper in their own lives. This is the greatest reward we can receive. It is what we hope for every day, to see people's lives change for the better.

We would greatly appreciate any assistance you can give us and promise you we will continue to do everything within our power to serve our community to the best of our ability. We are available for site visits if you would like to see our vision put into action. Please call to make an appointment.
